

## **View, Pay, Win with Online Bill Pay Official Rules**

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. Eligibility:** View, Pay, Win with Online Bill Pay (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia, who are at least eighteen (18) years old at the time of entry. A list of Participating Financial Institutions is included in Section 14. Employees of Fiserv Solutions, Inc., the Participating Financial Institutions, ePrize, Inc., and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. **3. Timing:** The Sweepstakes begins on October 1, 2013 at 12:00 a.m. Eastern Time ("ET") and ends on November 30, 2013 at 11:59 p.m. ET (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.

**4. How to Enter:** There are two (2) ways to enter the Promotion:

- a. Pay a Bill Using Online Bill Pay:** During the Promotion Period, pay a bill using your Participating Financial Institution's online bill pay service (see below for list of Participating Financial Institutions and their respective pools ("Pools)). For entrants into the US Bank prize pool only, payments must be greater than or equal to \$10; Payments cannot be made from a U.S. Bank consumer deposit account to yourself; and person to person (P2P) Payments are excluded. For every bill you pay online, the primary bill pay account holder of the account used to pay a bill online will automatically receive one (1) Sweepstakes entry into the applicable Participating Financial Institution's Pool ("Financial Institution Pool"), up to fifteen (15) entries per month per Financial Institution Pool, for a maximum of thirty (30) Sweepstakes entries for each Financial Institution Pool during the Promotion Period.
- b. Mail-in Alternate Method:** To enter without paying your bill online, hand print your name, address, day and evening phone numbers, email address (if any), and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "View, Pay, Win with Online Bill Pay," c/o ePrize, Inc., P.O. You will receive one (1) entry into each respective Financial Institution Pool. All mail-in entries must be handwritten and must be postmarked by November 29, 2013 and received by December 6, 2013. **Pool 4:** Both Regional and National Financial Institutions Pools Combined

**Limit:** You may receive up to a maximum of thirty (30) entries total for each Financial Institution Pool through any method or combination of methods described above during the Promotion Period. Multiple entrants are not permitted to share the same email address, and must have separate bill pay accounts for the purposes of entering the Sweepstakes. Any attempt by any entrant to obtain more than the stated maximum number of entries by using multiple/different email addresses, bill pay accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address or bill pay account used to register will be deemed to be the entrant. The "authorized account holder" of an email address is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The "authorized account holder" of a bill pay account is the natural person assigned the bill pay account by the applicable financial institution. Each potential winner may be required to show proof of being an authorized account holder.

**5. Drawings:** Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. On or around December 13, 2013, Administrator will randomly select the potential Prize winners from all

eligible entries received for each Pool during the Promotion Period. The potential winners will be notified by email, mail or phone. Except where prohibited, each potential Grand Prize and US Bank Grand Prize winner (or parent/legal guardian if winner is a minor in his/her state of residence) will be required to sign and return a Declaration of Compliance, Liability and Publicity Release which must be received by Administrator, within ten (10) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner of any prize cannot be contacted, or fails to sign and return the Declaration of Compliance, Liability and Publicity Release within the required time period (if applicable), the potential winner forfeits his/her prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
